Illinois DeafBlind Project Intervener Training Program Overview

The Illinois DeafBlind Project (ILDBP) Intervener Training Program is a free, hybrid (online and on-site coaching) program designed to:

- Train paraprofessionals already assigned to work with students, age 3-19 years with DeafBlindness who are on the ILDBP Child Count, and
- Support trainees (intervener candidates) through the online portfolio process in order to obtain the national credential, and subsequently apply for the Illinois Deaf-Blind Intervener approval.

The program requires that the intervener candidate's district administration and student's family support and consent in writing to the training and the creation of a credentialing portfolio. After approval is obtained and prior to in-classroom visits, an informational meeting will be provided by project staff with the student's teachers, related service providers, and other key team members. Both the training and the portfolio will require that photographs and video be taken of the focus student and intervener working together. As appropriate, student consent will also be acquired.

In return, ILDBP does not charge for any of the training services. The training includes:

- An online course of study: The training will utilize the *Open Hands, Open Access (OHOA) Deaf-Blind Intervener Learning Modules.*These modules, created by the National Center on DeafBlindness, have been tailored for the state of Illinois for this training program. The modules will provide overall content on DeafBlindness and provide intervener candidates all of the knowledge and skills contained in the Council for Exceptional Children's (CEC) standards for DeafBlind Intervention. Some modules will be assigned to address specific skills needed for an individual candidate to serve their specific student. Assignments will create items the intervener candidate may want to use in their future portfolio. Once all modules are successfully completed, intervener candidates can apply for an honorarium of \$50 per module (for a total of \$800).
- Meetings with ILDBP coach: A DeafBlind Specialist from ILDBP Illinois DeafBlind Services will meet as needed (face to face and virtual) with the candidate, as well as provide on-site coaching and consultation in the (a minimum of three observations to document skill acquisition and alignment with CEC standards).

- <u>Portfolio support from ILDBP:</u> When the training is completed, ILDBP will mentor the intervener candidates as they develop an online portfolio using the National Intervener Certification E-Portfolio System. The portfolio system is open to the candidate for one year, but with mentoring it is anticipated that candidates can complete a portfolio within four to six months using artifacts that have been collected during training. Opening a portfolio account currently costs \$75. ILDBP will reimburse the cost of the portfolio, AND provide a \$500 honorarium to intervener candidates whose portfolios grant them a credential.
- <u>Support during approval</u>: After certification is obtained, ILDBP will help intervener candidates complete the Illinois State Board of Education Intervener approval process. ILDBP will provide an additional \$500 honorarium to intervener candidates who become Illinois approved interveners.
- ONCE APPROVED, PARTICIPANTS CAN PROVIDE INTERVENTION AS A RELATED SERVICE ON AN IEP IN ILLINOIS. THE FULL PROCESS CAN TAKE 18 24 MONTHS.
